ASO FARAILLE, IANUARI 27, 1967GOVERNOR LEE SAYS PAN AM WILL INITIATE THIRD FLIGHT TO SAMOA

Governor H. Rex Lee talked to Acting Governor Owen S. Aspinall by telephone this morning and said that Pan American World Airways plans to start a third weekly flight from Honolulu to Samoa. The new service will begin March 1.

Governor Lee said it is not known at this time what day the new flight would be scheduled to arrive here, but he did imply that the initiation of the new flight may mean a completely new scheduling of all Pan Am flights to here.

The new flight, he added, will come here from Honolulu and continue on to Auckland and Sydney. It will apparently turn around and pass through Pago Pago while en route back to Honolulu, as the other two Pan Am planes do.

Donald Pegues, district traffic sales manager for Pan Am in Pago Pago, said he has expected the new service, but he has not yet heard any word about its initiation. He has wired Pan Am authorities in New York for details.

THREE JUDGES DECIDING ON MAUGA TITLE CASE APPEAL

An appeal of one of the most important matai titles on Tutuila -- the Mauga title -- is presently being decided upon by three judges of the Appellate Division of the High Court of American Samoa. The judges are Chief Justice Edward Hyden, High Chief Asuemu Fuimaono, and Talking Chief Te'i Masaniai.

The Mauga title, which according to Samoan custom includes jurisdiction of Ma'uputasi County (the bay area), had previously been awarded by the Trial Division of the High Court to Iulio Taufa'asau, of Pago Pago. But now an appeal has been made by three objectors who feel they are better qualified for the title. They are: Sialega Palepoi Mauga Jr., of Fatumafuti village, Ropati Manuma of Pago Pago, and Salanoa S.P. Aumoeualogo of Tula.

Oral arguments in the appeal case -- consisting largely of testimony showing each objector's qualifications for the title -- were heard in a packed court room Tuesday. Counsels represented Sialega Palepoi Mauga Jr. and Ropati Manuma; Salanoa S.P. Aumoeualogo acted as his own counsel.

The three judges have taken the testimony under advisement. It is not known when a decision will be forthcoming.

HONOR GUARD, SAMOAN CHIEFS TO MEET KING AND QUEEN OF TONGA MONDAY

A police honor guard and Samoan chiefs will assist Acting Governor Owen S. Aspinall in meeting the king and queen of Tonga when they arrive at the main dock Monday evening aboard the Tonga government vessel Hifofua.

The estimated time of arrive is 6 p.m., although this is subject to change.

King Taufa'ahau Tupou IV and Queen Halaevulu are on their way to London, England via Hawaii and San Francisco. Accompanying them on the trip are an aide de camp, Soiosia Ngalu Kalaniuvalu, and a lady-in-waiting, Miss Latunia Ahomee.

Deadline For Alien Address Report Nears (cont'd)

Aliens should go to the Immigration Division, Office of the Attorney General and ask for the Alien Address Report GAS form 472. When the form is filled out, it should be handed to an employee of the Immigration Division.

The following information is what is needed in order to complete the form:

1 -- Alien registration number; 2-- Address in American Samoa; 3 -- Sex; 4 -- Country of birth; 5 -- Date of birth; 6 -- Country of citizenship; 7 -- Date of entry into American Samoa; 8 -- Length of time alien has lived at the present address; 9 -- Occupation; 10 -- Name and address of most recent employer in American Samoa.

An alien who willfully or inexcusably fails to complete the Alien Address Report is liable to be deported or prosecuted.

FOUR MICRONESIAN WOMEN TO RECEIVE LIBRARY ASSISTANT TRAINING

SAIPAN, Mariana Islands, Trust Territory -- Four Micronesian women have left the Territory for Honolulu to participate in a three and a half month course in refresher education for library assistants sponsored by the East-West Center Institute for Technical Interchange and the Division of Library Services of the University of Hawaii and the Hawaii State Library System. The course is part of the Women's Career Development Program.

In addition to attending classes on various aspects of library operations the participants will study the operation of various general libraries, both private and public, as well as special libraries and bookmobile services. At the conclusion of their training, they will be assigned to work as apprentices with well-trained librarians.

MOTOR VEHICLE, DRIVER'S LICENSE DEADLINES DRAW NEAR

The public has only two more days to have their motor vehicles inspected and to obtain their new driver's license and license plates.

In order to obtain new license plates you must have your motor vehicle inspected for safety. The two inspection stations are located at the Tafuna Garage and the Utulei Motor Pool, and the hours of business are 8 a.m. to 3 p.m. Monday through Friday. An inspection permit costing \$1 must be obtained at the Revenue Office in Fagatogo before the inspection can be made.

Once a motor vehicle passes inspection, its owner is given a paper authorizing the issuance of new license plates.

New driver's licenses may be obtained from the police department.

The deadline for these requirements is January 31.

HONOLULU HOUSEWIVES PROTEST FOOD PRICES AT SAFEWAY STORES

HONOLULU -- A housewives organization called the Consumers Action Committee today is scheduled to boycott Safeway supermarkets in Honolulu to protest food prices.

The petticoat army is expected to descend upon Safeway outlets with heavy picketing at the Pali Highway store this morning. Although the boycott covers all four Safeway stores on Oahu, a spokesman for the group said picketing will not be extended to the other three stores until Tuesday.

At the same time, the group has dropped its boycott against Foodland-Food City, Times and North Shore IGA supermarkets.
