PORTLAND, OREGON MAN, 34, NAMED ATTORNEY GENERAL OF SAMOA

The appointment of a 34-year-old Portland, Oregon attorney to the post of attorney general of American Samoa was announced yesterday by Governor H. Rex Lee.

Charles H. Habernigg, presently assistant U.S. attorney in charge of the criminal division, will arrive by Pan-Am next Sunday. Habernigg will replace Alfred Gergeley who will return to the mainland to practice law.

Habernigg has had a far-range of experience in his six years with the U.S. Attorney's office in Portland. He has worked in such areas as anti-trust, postal fraud, counterfeit, forgery, secret service, immigration and narcotics.

Prior to government service, Habernigg was with a Portland law firm and had a variety of civil law practice.

Habernigg is a native of Blackwell, Oklahoma, though he grew up in Wichita, Kansas. He did his under graduate work at Oberlin College in Ohio, where he was an Economics major. He was class president, a member of the debating team, captain of the wrestling team and a quarter-back on the football team.

Habernigg won a three-year scholarship to Yale University Law School in New Haven, Connecticut. While studying law at Yale he taught Economics in the undergraduate school there. He was a Woodrow Wilson fellow at Princeton University in New Jersey where he did graduate study in Political Economics. He also attended summer school at the University of Oslo in Norway.

American Samoa's new attorney general is married to the former Jill Spence and they have two children. Mrs. Habernigg and the children will come to American Samoa at the close of the school year in May in Portland.

Mrs. Habernigg is a native of Rochester, New York. She is a graduate of Duke University in North Carolina and earned her master's degree in education at Radcliffe College in Cambridge, Massachusetts. She is presently an assistant professor of education in Portland State College.

Almost all of the 24 photographs in the album are in color; they were shot by official White House photographers. They show representative scenes of the President's visit here, plus individual photographs of High Chief Rapi Sotoa, Chief Pula and Chief Le'iatu. Many other Samoans, including school children, are in the photographs.
